**Students receiving Maricopa Grant program funds are subject to the following criteria:**

- **Satisfactory Academic Progress-** All credits attempted will be reviewed for completion at the end of the semester or term. Students who did not successfully complete a course will be reviewed for continued scholarship eligibility. Grades of Z, I, W, Y, %, or F **DO NOT** count as credits completed (including on-line classes). Students should progress systematically in their course selections. Repeat classes will not be funded.
- **Regular Status-** All regular status students are encouraged to enroll in an eligible program for the purpose of pursuing a degree or certificate. Students who are undecided about their academic goal will need to justify their enrollment.
- **Federal Financial Aid-** Students awarded federal financial aid will not be eligible for Maricopa Grant / EMCC Assistance Scholarship Funds.
- **Limitations-** Students who have earned/attempted 72 credits, have earned a degree or have reached the maximum timeframe of 6 terms of half-time will no longer be eligible for the Maricopa Grant / EMCC Assistance Scholarship Funds.
- **Financial Need -** Scholarships will be awarded based on financial need. Scholarships will be awarded on a first come, first serve basis until funds are deleted.
