Employee Tuition Waiver Quick Facts:

- Employee must complete the admissions process and enroll in classes prior to submitting their tuition waiver.
- For eligible Maricopa Community College employees: For additional information related to eligibility, guidelines, and terms of use please review the [MCCCDC Tuition Waivers and Handbook](#).
- Employee Tuition Waivers cover up to 12 credit hours per semester.
- Maricopa Tuition Waivers **do not cover** the registration fee, course fees, or out-of-state charges.
- The employee will need to complete an Employee Tuition Waiver for each campus if using the tuition waiver at more than one campus.

Employee Tips for Filling Out Tuition Waiver Forms

Recently, the Dynamic Waiver Forms process was launched for [eligible employees](#). The project team has some tips to highlight when filling the form out:

1. **If using the same computer**, the employee and supervisor should log out of the Dynamic Form after completing the entry (vs. simply closing out of the page).



How to complete an Employee Tuition Waiver:

1. The employee will sign into the Dynamic Form using the following hyperlink: [Employee Tuition Waiver](#) using the students' MEID and password. The form will autofill the **EMPLOYEE INFORMATION**, except the Job Location, Work Hours and Day Time Phone section.

2. The employee will continue to complete the requested information on **College and Course Information**:
 - a. Select the college in the drop-down menu. The employee will need to complete an Employee Tuition Waiver for each campus if using the tuition waiver at more than one campus.
 - b. Select the term in the drop-down menu.
 - c. Enter the course Prefix, Class Number, Days, Times, and Credit Hours. (If the class is online, enter online).
 - d. The form will provide one line requesting the course information and will generate a new row after the second course prefix has been entered.

- * ☒ The waiver for the above-listed class(es) is for the **in-county credit-hour cost only** (does not include out-of-county, out-of-state, distance learning or other surcharges); waiver for no other fee is expressed or implied by the acceptance of this request. Credit by examination or evaluation is not eligible for waiver.
- * ☒ Acceptance of this request by the Student Business Services Office does not imply that it has been approved. Eligibility will be based on state statute and MCCCDC policies and regulations. If it is determined that I am not eligible for a waiver, I understand and agree that I am responsible for paying the full student cost of any courses I am enrolled in as of the drop/add period for the course(s). Eligibility may or may not be verified prior to the end of the drop/add period.
- * ☒ The number of withdrawals for the same course number (i.e., ECN211) is limited to two (2). Upon the third attempt, I may not use a tuition waiver to register for any course for which I have previously received two W, Y, Z or F grades and I must pay applicable course costs. The intent of this limitation is to address the potential (or possible) misuse of public funds for any activity indicating a pattern of non-participation, non-attendance and non-completion (e.g., multiple withdrawals or "Z" grades--see Enrollment Irregularities below).

*A Full-Time Classified, Non-Classified or Specially-Funded employee is a regular employee who is compensated from .75 to 1.0 FTE. **One-Year-Only (OYO) and One-Semester Only (OSO) working less than full-time and Temporary employees are not eligible for tuition waivers.**

Student Business Services Portion

- Student Business Services will receive an email that an Employee Tuition Waiver needs to be reviewed. An associate will review the form and ensure that the following has been completed:
 - a. The employee completed the correct form
 - b. The employee is enrolled in the classes listed on the Tuition Wavier request
 - c. The required course information is entered on the form.
 - d. The registration and course fees if any are paid.
 - e. Additional signatures are completed if necessary.
- Student Business Services applies the waiver to cover the course(s) if the form was completed correctly, enrollment matches the request and payment has been submitted. The account will display a zero balance at the campus related to the request.
- If the request is missing one or any of the items for review the form is returned and the employee is notified to their Maricopa email with the reason(s) the request could not be completed and directing the student to resubmit the Employee Waiver with the proper information.
- After the Refund Deadline has passed the Manager of Students Business Services will review and provide final approval of the waiver.
